1.4 Order of Precedence

In the event of any conflict between any of the following documents, the order of precedence between them shall be as follows:

- a. If applicable, the relevant Frame Agreement or Special Purchase Conditions, and their annexures (once signed); and
- b. The relevant purchase order;
- c. These GPC

1.5 The Supplier undertakes to accept the purchase order by returning the order confirmation within a period of two weeks, failing which the Customer shall be entitled to cancel the purchase order. In case the order confirmation deviates from the purchase order (even if such deviations are not material), such deviations shall only come into existence if the Customer expressly consents thereto. If the Supplier commences any work in relation to a purchase order prior to conveying its express acceptance to such purchase order, all costs and expenses incurred by the Supplier in such work shall be to the account of the Supplier. The Customer shall bear no responsibility for such costs and expenses, if the Customer cancels the purchase order for failure by the Supplier to confirm the purchase order within the above mentioned period of two weeks.

1.6 The Supplier undertakes that it is solely responsible for obtaining all means and resources necessary for the performance of its obligations under the relevant purchase order including licenses, permits, consents, authorisations, etc. from third parties in connection with the goods and services.

2. Quantities, Delivery, place of performance, failure to meet delivery times, business interruption

2.1 Supplier acknowledges that the Customer's requirements for the goods may fluctuate in response to changes in production volumes and/or technical changes and/or due to the changes in their end customer's requirements. Consequently, the Supplier acknowledges that any quantity of goods stated to be required by the Customer is communicated to the Supplier for information purposes only and shall not be construed as the Customer's commitment to place purchase orders in respect thereof.

2.2 The Supplier agrees to provide the flexibility required to adapt to the fluctuations in the Customer's requirements referred to in Section 2.1 above.

2.3 The Customer shall endeavour to keep the Supplier informed of the market position to the extent possible and may provide the Supplier with a periodical forecast.
